SECOND PUBLIC HEARING - ORDINANCE NO. 2014-01 – CRA BOARD APPOINTMENTS

Betty Webb read Ordinance No. 2014-01 by title as follows:

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF APALACHICOLA AMENDING THOSE PROVISIONS OF ORDINANCE NUMBER 2008-04 PERTAINING TO THE APPOINTMENT OF BOARD MEMBERS OF THE APALACHICOLA COMMUNITY REDEVELOPMENT AGENCY; REPLACING THE EXISTING SEVEN MEMBER BOARD WITH AN EIGHT MEMBER BOARD; ESTABLISHING STAGGERED TERMS TO SERVE TWO-YEAR AND FOUR-YEAR TERMS; DESIGNATING BOARD MEMBER SLOTS TO BE FILLED; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; AND ESTABLISHING AN EFFECTIVE DATE.

Attorney Floyd read Ordinance 2014-02 by title as follows:

AN ORDINANCE BY THE CITY COMMISSION OF THE CITY OF APALACHICOLA AMENDING THOSE PROVISIONS OF ORDINANCE NUMBER 2009-05 (AS AMENDED BY RODINANCE NO. 2010-01) IN PART WITH REFERENCE TO SECTION 5. HOURS OF OPERATION AND SECTION 3. REGARDING THE EQUIPMENT ON SAID GOLF CART TO PERMIT IN ACCORDANCE WITH FLORIDA STATUTES SECTION 316.212 PROPERLY EQUIPPED GOLF CARTS TO OPERATE ON THE DESIGNATED STREETS WITHIN THE ORDINANCE DURING THE HOURS BETWEEN SUNSET AND SUNRISE; PROVIDING FOR THE CONTINUED VALIDITY AND ENFORCEMENT OF ALL OTHER PROVISIONS OF ORDINANCE NO. 2009-05 AS AMENDED AND PROVIDING THAT TO THE EXTENT OF CONFLICT THIS ORDINANCE SHALL SUPERSEDE AND TAKE PRIORITY OVER CONFLICTING PROVISIONS OF OTHER ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

4 WAY STOP REQUEST

Ms. Webb reported that requests were made to put 4 way stops at Commerce St. and Avenue D, Commerce St. and Avenue E and 11th St. and Avenue F.

1. Ms. Webb reported that the bids for the Wet Weather/Reject Storage Pond Project have been received, Gulf Coast Utility Contractors was low bid at \$638,077.50, recommendation to award has been made by BDI.

Mike Stanley from BDI stated that Gulf Coast Utility Contractor is a very reputable business and will do a great job for the city.

OTHER VISITORS AND COMMENTS

1. Mr. Jerry Weber spoke up about people representing his neighborhood at the end of 7th Street. He stated people speed and throw trash out everywhere. Mr. Weber gave the commission photos of offences being committed in the neighborhood and asked that something needs to be done about this. Mr. Weber asked that the end of 7th Street be closed and made available for emergency vehicles and walking path.

Discussion held.

Attorney Floyd will research this and have for next city commission meeting.

Mayor Johnson asked that this also be brought to the Community Pride for review.

2. Mr. Noah Lockley stated that there are too many stop signs in town and that city needs to take some out.

Mr. William Key agreed that there are too many stop signs in town.

Ms. Carol Barfield agreed that there are too many stop signs in town and too many speed bumps in neighborhood areas. Ms. Barfield stated if there is a problem with speeding, write tickets.

Mr. Harrison Jones agreed that there are too many stop signs and speed bumps in his neighborhood. Mr. Jones stated that Bay Avenue had stop signs and that they are now gone. Mr. Jones asked how this was done.

Ms. Webb stated that citizens filed complaints with the Commission and that they agreed to have them removed.

Mayor Johnson stated he would have Chief Bobby Varnes look into this.

Commissioner Elliott asked if the city has workable radars in the police department.


Officer Lewis stated they do and that everyone is certified to use a radar gun.

Board agreed to have this topic be part of Community Pride discussion.

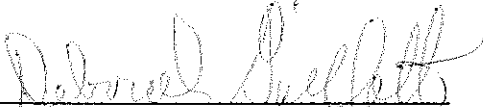
3. Commissioner Elliott asked what was going on with Greg Harris's promotion to street supervisor.
