PUBLIC HEARING – CDBG PROJECT APPLICATION

Debbie Roumelis stated the funding cycle for CDBG grants is now open and applications are due by June 22nd. Ms. Roumelis stated funding for commercial revitalization projects will be very minimal this year, and recommends the City pursue either the housing rehabilitation option or the neighborhood revitalization option. The CDBG Citizen's Task Force met and recommends the City pursue the neighborhood revitalization project. Ms. Roumelis explained this grant is up to \$650,000 which would entail sewer extension around Avenue M, Earl King St., and 20th to 21st Avenue to 12th Street areas. Ms. Roumelis further explained that this project would also include upgrading the Bobby Cato lift station, and if funds were available, water meters would also be replaced in these areas.

Ms. Webb stated that the City should be able to provide sewer to those residents in the Jacobie Lane area with this sewer extension because the extension would make sewer available be within 200 feet.

Ms. Roumelis stated she is still compiling income data for households in the target area.
