A workshop of the City Commission of the City of Apalachicola was held on Tuesday, January 15, 2013 at 6:00 PM at the Apalachicola Community Center, #1 Bay Avenue, Apalachicola, Florida.

Workshop opened by Mayor Pro-Tem Cook followed by prayer and pledge.

Attorney Floyd stated this is the first workshop to discuss local Restore Act project applications. Attorney Floyd outlined the application process and on how Restore Act distribution formula is calculated.

Mayor Pro-Tem Cook stated it is important to look and listen to everyone's ideas.
