
MINUTES

Present: Tom Daly – Chairman, Geoff Hewell, Jim Bachrach, Uta Hardy, Lynn Spohrer, Cindy Clark – Planner, Betty Webb – City Administrator

Regular Meeting – 6 p.m.

- 1) Chairman Tom Daly speech/discussion
Last couple meetings have been disorderly, and he apologizes. He reminds the board to use Roberts Rule of Order. He asks the Board and Audience to speak when acknowledged by Chair, Sidebar conversations discontinue, No negative reference to individuals, staff or community and No hats. Recognize Lynn Wilson-Spohrer as the new Vice Chair.
- 2) Approval of June 2015 Special Meeting Minutes & July 2015 Regular Meeting Minutes.
Question was raised about DRAFT Minutes being posted online. Betty Webb stated she will check with Lee that she and Cindy Clark were going to be working on that. Motion to approve minutes with changes as stated was made by Geoff Hewell, Second by Jim Bachrach. Motion carried.
- 3) Review, Discussion and Decision on roofing permits:
 - a) Shingle to metal roof (galvalume in color) over sunroom at 87 5th Street, Block 8, Lot(s) 8-9, For – Dolores Roux, Contractor - Bobby James Inc. **(Leaking roof emergency approval given 7/23/15)**
Motion to approve made by Geoff Hewell, Second by Jim Bachrach. Motion carried.
 - b) Shingle to metal roof (galvalume in color) at 5 Ellis VanVleet Street, Block 249, Lot(s) 11.5 ft of 5 and all of 6-9, For – William Johnson, Contractor - Self. **(Leaking roof emergency approval given 7/29/2015)**
Motion to approve made by Geoff Hewell, Second by Jim Bachrach. Motion carried.
- 4) Review, Discussion and Decision on permit issuance for 6' high privacy fence @ 29 17th Street, Block 109, Lot(s) SW ½ of 6 and 7, For – Robert & Ethel Jenkins, Contractor – Self. **(After the fact)**
Ethel Jenkins said it's temporary fence around pool, they've been doing it every year for some time. Some sections they may want to leave up. Geoff Hewell stated remove May or Sept. Pete Adams stated there is a temporary, portable fence available. Geoff Hewell said they will remove after summer. Tom Daly stated this sets a precedence. Motion to approve for 4 months was made by Geoff Hewell, Second by Lynn Wilson-Spohrer. Motion carried.
- 5) Review, Discussion and Decision on permit issuance for 4' chain-link fencing (black or silver) or 3' or 4' wood picket fence in front yard and 6' privacy in back and side yards @ 168 21st Avenue, Block 245, Lot(s) 4 and 5, For – Regina and Ron Ramfjord, Contractor – Pete Adams.
Motion to approve 4ft picket in front with low wire against the 2 6ft privacy sides and picket or privacy in rear was made by Uta Hardy, Second by Lynn Wilson-Spohrer. Motion carried.
