Proposed milage rate: 6.125%

Rolled back rate: 6.40%

Proposed milage rate is a 4.30% decrease from the rolled back rate.

WHICH THE MILAGE RATE TO BE LEVIED EXCEEDS THE ROLLED BACK RATE; AND PROVIDING AN

EFFECTIVE DATE.

Mayor Johnson stated that he talked with Ms. Webb earlier to see if there were any areas that could be

cut, and was told that all expenses are cut to bare bone.

Commissioner Cook stated that the increased fees that were addressed by the Budget Committee are

not included in this budget. Those proposed fees will be addressed at a later date.

Mayor Johnson stated he is having concerns about paying a lobbyist \$12,000. That is almost ¼ mill.

Commissioner Cook stated it is getting harder and harder to get money out of the State. A lobbyist can

work with legislators and has a much better chance of getting money for the City. Commissioner Cook

stated he feels it would be money well spent.

Mayor Johnson stated that each of the engineering firms that were just ranked also do lobbyist work.

Commissioner Cook stated those firms are not motivated to serve just the City like our own lobbyist

would be. Commissioner Cook stated he feels it would be worthwhile to have a lobbyist for one year,

and if it doesn't work, then quit it next year.

Mayor Johnson stated if the City could afford it that would be one thing, but the City just can't afford it

at this time.

Discussion held concerning employee raises, Dixie Theatre, and lobbyist.

Ms. Webb addressed overtime policy, Mediacom property rent, correction to group insurance, and

vehicle.

Discussion continued regarding employee raises.

Motion to adopt Resolution 2008-06 setting the FY 2008/2009 milage rate at 5.96 made by

Commissioner Cook, second by Commissioner Webb.
