ALLEYWAY PAVING - 120' BEHIND OLD FAIRPOINT TELEPHONE OFFICE BUILDING

Ms. Webb stated that an application has been submitted from Sacred Heart to Planning & Zoning to pave 120' behind the old Fairpoint telephone office building located on the corner of 4th Street and Hwy 98. Ms. Webb stated that Planning & Zoning recommended approval to allow paving if all storm water permitting requirements are met or use some type of pervious type material so as not to cause storm water problem. Ms. Webb stated that Planning & Zoning did not want paving to cause problems with the surrounding property owners.

Harry Bell, representative from Sacred Heart, stated that building will be used for a pediatric clinic. Paving the alleyway will allow for better access in and out of the alley.

Ms. Webb recommends having the City's storm water engineer review proposed paving to make sure all requirements are being met if a pervious material is not used.

Attorney Floyd stated that Sacred Heart will also be required to maintain the paving and will have to sign a hold harmless agreement for the paving.

Ms. Webb stated there are also water and sewer lines that run in the alley. If paving has to be torn up to repair any lines, then Sacred Heart will be required to repave with no expense to the City.

Commissioner Cook stated the City already has a lot of drainage problems in that area so the City just needs to let the engineer look at it to make sure new problems are not being created. Also, it needs to be understood that the alleyway is still City owned property. Commissioner Cook stated he has a problem with giving up use of an alleyway to conduct business.

Harry Arnold stated the alleyway will be used to exit the property only.

Leon Bloodworth stated they will only have ingress and egress into the alley.

Ms. Webb stated main entrance would be on 4th Street.
